

TALENT AUDITIONS SERVICES CONTRACT

1. **SERVICES:** I employ Talent Auditions LLC to provide coaching and guidance and I agree to attend level 5 program consisting of 8 rehearsals in Acting and/or Advanced Acting and one agent showcase under the terms and conditions herein. Talent Auditions LLC reserves an opening for you in this limited program beginning 04/16/2024.
2. **FEES:** In rendering services, I agree to pay Talent Auditions LLC in the total amount of \$3500.00 to be paid in full upon execution of this contract and not later than the end of this contract, on the final showcase date of 06/08/2024. Attendance is your responsibility as scheduled in the contract and outlines. Any failure to attend rehearsals during the period designated shall not relieve you of your obligation to pay under the contract. Any delay on the part of Talent Auditions LLC shall not be deemed a waiver of those rights.
3. **ASSIGNMENT:** This contract is not assignable without the express written consent of Talent Auditions LLC.
4. **BREACH:** You agree to pay any costs associated with the collection of any monies owed as well as reasonable attorney's fees in the event Talent Auditions LLC is required to pursue any action to enforce breach under this contract.
5. **APPLICABLE LAW:** The parties expressly agree that any dispute or controversy resulting from the relationship specified herein shall be governed by the laws of the state of Illinois.
6. **ARBITRATION:** Any controversy or claim brought by you arising out of or relating to this contract, whether for breach or any other reason, shall be settled through binding arbitration administered by the American Arbitration Association under its Commercial Arbitration Rules. The number of arbitrators shall be three. The place of arbitration shall be Chicago, Illinois. Client is responsible for any filing fees or administrative fees related to the Arbitration. Both parties agree to maintain confidentiality and not disseminate the nature of the dispute or that said arbitration occurred. I expressly agree that any damages that I may have or allegedly have had as a result of the services herein is expressly limited to the out of pocket payments made to the contractor.
7. **ENTIRE AGREEMENT:** This contract constitutes the entire agreement and understanding of the Parties as to the subject matter thereof. The undersigned acknowledge that there are no communications or understandings, oral or written, contrary to, different from, or which in any way restrict this agreement. Talent Auditions does not guarantee employment of any kind or make any other promises thereto.
8. **MODIFICATION:** This contract may not be modified except by a writing subscribed by all parties hereto.
9. **COLLECTIONS:** I understand if I have an unpaid balance to Talent Auditions LLC and do not make satisfactory payment arrangements, my account may be placed with an external collection agency. I will be responsible for reimbursement of the fee of any collection agency, which may be based on a percentage at a maximum of 35% of the debt, and all costs and expenses, including reasonable collection and attorney's fees incurred during collection efforts. In order for Talent Auditions LLC or their designated external collection agency to service my account, and where not prohibited by applicable law, I agree that Talent Auditions LLC and the designated external collection agency are authorized to (i) contact me by telephone at the telephone number(s) I am providing, including wireless telephone numbers, which could result in charges to me, (ii) contact me by sending text messages (message and data rates may apply) or emails, using any email address I provide and (iii) methods of contact may include using pre-recorded/artificial voice message and/or use of an automatic dialing device, as applicable. Furthermore, I consent the designated external collection agency to share personal contact and account related information with third party vendors to communicate account related information via telephone, text, e-mail, and mail notification.
9. **CANCELLATION:** This contract may be cancelled within three (3) days of execution. After the three day cancellation period, payments are non-refundable due to the nature of the program and considerable effort and time spent by Talent Auditions LLC in orchestrating and pursuing this contract and the services herein. Marketing and showcase rehearsals begin immediately after acceptance, and the spot is filled by you. To cancel this contract, you must send an email to info@talentauditions.biz. You will be refunded within 21 days of Talent Auditions LLC's receipt of your request thereto.

1. **Talent Auditions is a training and marketing company, not a placement or employment agency, and does not promise a job at the completion of any training.** However, Talent Auditions will market you to agencies and attempt to do everything they can to find representation for you. It is understood that Talent Auditions cannot pressure or coerce any individual, agency, client, or company to secure a modeling or acting assignment for talent.
2. The general pay rate for talent varies from minimum wage to more than \$100.00 per hour, depending on the assignment. If a talent is booked for an assignment, agencies usually charge from 10% to 20% commission per assignment. Talent who are booked for assignments work as independent contractors and are never employees of Talent Auditions or the agency that books the talent for the assignment. Independent contractors are governed by specific tax and labor laws, which vary by State and you are responsible for any and all obligations of an independent contractor.
3. It is understood that payments must be current to continue classes, participate in the agent showcase, and receive marketing.
4. All communication with any team member of Talent Auditions must be through a parent or legal guardian. Email addresses and phone numbers must belong to the parent, not the child.
5. Client and parent(s) are to remain professional at all times.
6. Client and parent(s) are responsible for finding a gender and age appropriate comedic 60 second monologue.
7. Client and parent(s) are responsible for creating a profile for the client on Talent Audition's website after the agent showcase.
8. If you do not receive the welcome email within 24 hours, email info@talentauditions.biz.
9. If you have not received Zoom links by the Thursday before your first session, email info@talentauditions.biz.
10. Please be on time for your rehearsals. You may not be let in if you are more than 10 minutes late. Early is on time and on time is late.
11. You are to only attend the number of sessions in your program, no more, no less.
12. If you cannot attend a session, email info@talentauditions.biz immediately. Do not wait until sessions are completed before reaching out.
13. You will be responsible for a \$25 no show fee for missed 1-1 sessions that you miss, unless you have spoken with the office beforehand.
14. Talent Auditions welcomes all questions, concerns, and feedback. Please do not hesitate to reach out.
15. In consideration of the potential, future, publicity, you hereby grant Talent Auditions the right to copyright and/or reproduce, anywhere in the world forever any photographs, video, television, and other tapings, and recording of you for advertising and publicity.
